

Rules for Constitution and Functioning of

The Education Committee Of The Maheshwari Samaj (Society), Jaipur

The Education Committee of the Maheshwari Samaj (Society), Jaipur shall be regulated by these rules and regulations for carrying out its functions to achieve the objects as specified in its Memorandum of Association.

In these rules and regulations, unless the context otherwise required.

- (a) 'Committee' means The Education Committee of Maheshwari Samaj (Society), Jaipur.
- (b) 'Head of Institution' means Principal Academic officer by whatever name called of the institution.
- (c) 'General Secretary' means the Education General Secretary of the Society.
- (d) 'Secretary' means Secretary of the managing committee of the respective educational institution under Society.
- (e) 'Member' means the member of the Society.




CLAUSE 1 :

- (a) The Education Committee of The Maheshwari Samaj (Society), Jaipur will consist of following members. The Executive Committee of The Maheshwari Samaj, Jaipur soon after its constitution, every three years shall nominate members including the President, one out of the Vice Presidents, the General Secretary Education, Education Secretaries for each institution, Building Secretaries for each institution, and the Treasurer (Education) of the Samaj as office bearers who will hold the same posts in the Committee and the remaining one member as ordinary member. The President of the Samaj shall nominate three eminent persons belonging to The Maheshwari Samaj, Jaipur, the age of whom shall not be less than 50 years. The existing Samaj Secretary (*Maha Mantri*), immediate past President of the Samaj and immediate past General Secretary Education shall be ex-officio member. Any vacancy arising out of any reason whatsoever shall be filled by the Executive Committee of The Maheshwari Samaj, Jaipur. All the members shall enjoy similar powers.
- (b) The powers, functions and jurisdiction of the President, Vice President, General Secretary Education and The Education Secretaries shall be as per the Constitution and Rules & Regulations framed by The Education Committee of The Maheshwari Samaj (Society), Jaipur from time to time.

CLAUSE 2 :

The members of the Committee shall hold office for three years or till formation of new ECMS by the newly elected Executive Committee of the Maheshwari Samaj member(s) appointed to any vacancy during the current period of the committee shall hold office upto the end of the tenure of the committee.

CLAUSE 3 :

- (a) The Society shall Control, assets, funds and income of the Society to be utilised for Education purposes and for achieving the said object to maintain, run, develop and improve its already functioning institutions and to establish school(s), College(s) or any other educational institutions, hostels and other amenities for the benefit of students solely or for educational purposes and not for purposes of profit.
- (b) The Society may receive contributions / donations or money and / or properties from any person.

CLAUSE 4 :


The Society shall ensure that its Institutions get proper land, building, equipment, furniture and qualified staff at least as per the norms of the State Education Department / Board.


CLAUSE 5 :


That in consonance with the provisions of Rajasthan Non-Government Educational Institution Act, 1989 (Act 19 of 1992) & the rules made there under,

- (a) The Society shall take all necessary steps for constitution of separate Managing Committees for its Educational Institutions in accordance with the prevailing rules made by Government of Rajasthan, Central Government and/or by their Boards or Education to which each institution stand affiliated.
- (b) The Society shall frame regulations / bye laws of Managing Committee for its Institutions in accordance with the prevailing rules made by Government of Rajasthan, Central Government and/or by their Boards or Education to which each institution stands affiliated.
- (c) The Committee shall have power to amend the regulations/by laws for its Institutions.
- (d) The Managing Committee of each Institution shall cease to hold office as soon as the new managing Committee is formed. Soon after formation of the incoming Managing Committee the outgoing Committee shall notify the names of incoming Managing Committee to the respective

Head of Institution, Government Department, Banks and Secretary of outgoing Managing Committee who will handover complete charge of the all the records, assets etc. to the Secretary of incoming Managing Committee.

CLAUSE 6 :

An ordinary meeting of the Society shall be called by the General Secretary once in every two months, emergent meeting may be convened whenever necessary. A special meeting shall be called by the President when a requisition for such a meeting is made by not less than two-third (2/3) of the member of the Society. But in case the President fails to call the meeting within fifteen days of the receipt of such requisition, the meeting shall be called by the signatories to the requisition and their decision shall be final Three days notice shall be given in the case of ordinary meetings. In the case of emergent meetings twenty four hours notice shall suffice. All meetings shall ordinarily be held on the school premises.

CLAUSE 7 :

The notice of each meeting shall set-forth the business to be transacted at the meeting and no other business shall be transacted except with the consent of the President.

CLAUSE 8 :

One third of total no. of members shall form quorum in absence of which the meeting shall be adjourned and the next meeting will take place within twenty four hours, at least after, with due information to all the members.

CLAUSE 9 :

In the absence of the President, the Vice-President shall preside over the meeting, and if both are absent, then one of the members present shall be elected to preside over the meeting.

CLAUSE 10 :


The President of the meeting shall have casting vote in addition to his ordinary vote, when votes of the members present are equally divided.


CLAUSE 11 :

At each meeting the first item of business shall be to read and confirm the proceedings of the previous meeting.

CLAUSE 12 :

The member without reasonable cause failing to attend Three consecutive meetings of Society, shall cease to be a member of Society and vacancy so caused shall be duly filed by the Society, However, leave of absence may be granted by President.

CLAUSE 13 :

The proceedings of the meeting(s) of Society shall be recorded regularly in the Minute Books to be retained for the purpose.

CLAUSE 14 :

Proper accounts shall be maintained for the Society in respect of its (Assets & liabilities),(Income and Expenditure).

CLAUSE 15 :

The accounts of the Society shall be yearly got audited by Chartered Accountant(s) duly appointed by the Society. The audited accounts shall be placed in the meeting of Society at the first ordinary meeting following its receipt. The Society may appoint internal auditors for concurrent audit of accounts.

CLAUSE 16 :


The Society only shall be empowered to decide.


- (a) to establish the new Institution.
- (b) to open a new section of Class in any of its Institution and/or to close any section of a class on recommendation of The concerned managing committee.
- (c) to change or modify the medium of coaching and instruction of a institution on recommendation of The concerned managing committee.
- (d) to fix (fee(s) to be charged from students of each class of its institution and periodically revise them.
- (e) to consider and pass with or without modification budgets of its institution prepared by The General Secretary, Secretary of The concerning institution, The Treasurer and The Principal duly forwarded by the Managing committee of the concerning institution.
- (f) to accept donations of money and/ or properties.

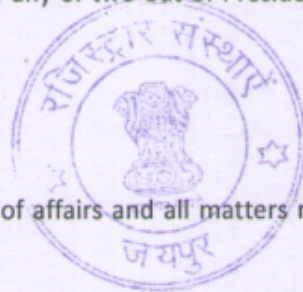
- (g) to acquire immovable property.
- (h) to invest funds in Nationalized Banks, in Government Securities, and to dispose of, transfer and otherwise deal with them.
- (i) to frame rules and regulations in respect of any scheme for the benefit of teaching and non-teaching staff.
- (j) to appoint Principal and Vice Principal for its institution.
- (k) to sanction and approve the appointment of teachers and staff made by the managing committee of its institution on adhoc and/or temporary basis are on probation .
- (l) to decide about additional/extra increments, ex-gratia payments, perks additional bonus on the basis of the performance of the staff as per recommendation of the managing committee.
- (m) to constitute a Central Purchasing Committee for deciding the rates and suppliers for bulk purchasing by its institution and to give direction as and when necessary.

CLAUSE 17 :

Bank accounts or accounts shall be opened for the Society with any Nationalized Bank or Banks which shall be operated by joint signatures of any of two out of President, General Secretary and Treasurer of Society.

CLAUSE 18 :

The Committee shall have general directions of affairs and all matters relating to the Institutions brought before the Society.






CLAUSE 19 :

The proceedings of the Society and all its acts and correspondence shall be carried out through General Secretary who subject to overall control and superintendence of Society shall have power to deal with any matter relating to the Society. In the absence of General Secretary, any Secretary nominated by him shall work in his place. The General Secretary may divide his function amongst Secretaries if required.

CLAUSE 20 :

The Society shall have control over any capital expenditure on lands, construction of buildings or their expansion and procurement of major equipments for its institutions.

CLAUSE 21 :

The Society shall ensure that its institutions are running as per the provision of the Education Act/affiliation norms and shall be committed to provide quality education to the children and shall for this purpose take all necessary steps as and when needed.

CLAUSE 22 :

The Society may frame rules and regulations as to the duties and responsibilities of its office bearers / members and to appoint sub-committees, Adhoc Committees to run new institution as deemed necessary. All these sub committees & adhoc committees will automatically dissolve as soon as new committee takes over.

CLAUSE 23 :

The General Secretary shall, as directed by the Society file suit on behalf of the Society and likewise defend any suit against the Society.

CLAUSE 24 :


The General Secretary shall pass all payments of bills upto a maximum amount of Rs. 10,000/- . The bill for more than Rs. 10,000/- shall be paid subject to the approval of the President and the payment order will bear the signatures of both the General Secretary and the President.

CLAUSE 25 :

The Maheshwari Samaj, Jaipur, the sponsor of the Maheshwari Educational Institutions, shall be responsible for setting apart an adequate sum of money exclusively for running the institutions. The said sum of money handed over in the custody of The Education Committee of the Maheshwari Samaj (Society), Jaipur who shall deposit it in a Nationalized bank or invest it in Government Securities in the name of the specified institutions and utilize only the interest thereof to make the expenses. The Society shall take concurrence of Executive Committee of Maheshwari Samaj, Jaipur on matter(s) of importance. An annual Report shall also be submitted to the Maheshwari Samaj, Jaipur in lieu of its patronage and ever accessible helping hand.

CLAUSE 26 :

Any amendment in these rules and regulations shall only be made by a resolution passed at a meeting convened after 15 days prior notice of the proposed amendment and a clear majority of 2/3rd of the total number of the members of the Society.





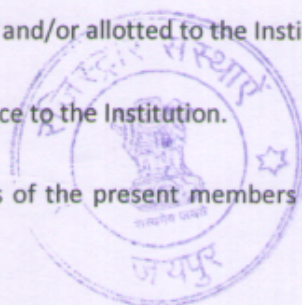
THE EDUCATION COMMITTEE OF THE MAHESHWARI SAMAJ (SOCIETY), JAIPUR

1. The Name of the Society is "The Education Committee of the Maheshwari Samaj, Jaipur City."
